

Well Known Kinkora Man Dies In Hospital

The death occurred in the Prince County Hospital on Wednesday, February 23rd, of Mr. Theodore A. McIvor, at the age of eighty years. Although he had been in failing health for some months it was not until a few days ago that he was taken to the Prince County Hospital for treatment and a wide circle of friends learned with regret of his serious condition.

The late Mr. McIvor was born at Newton, the son of the late John and Emily McIvor, and in his early years moved to Kinkora where he operated a general store for some years, until he entered the employ of the International Harvester Company as their Island representative. Some years later he opened up a produce business in Kinkora and represented the CIL Fertilizer Division, until his retirement several years ago when he moved to Summerside where he has since resided. During his long and useful life he made a host of friends who held him in high esteem for honesty and integrity in business and his passing removes one who on many occasions proved himself to be a friend to all who were in need of assistance.

He leaves to mourn his widow, the former Adella Johnston, four sons, Charles and Harold in Summerside, John D. in Winnipeg and Emmett in Sarnia, Ont.; four daughters, Mrs. J. A. Brown, Grand River, Mrs. Everett Kelly, Summerside, Mrs. Mark Hagen, Toronto and Mrs. Don McPherson of Borden. The sympathy of the community is extended to the bereaved family.

Weather conditions permitting the body will be removed from his late residence in Summerside this afternoon and taken by train to Kinkora to the funeral home of P. A. Monaghan. The burial service will be held on Friday morning at 9 o'clock.—S
